Tuition Information 2010-2011 School Year

Students are charged **ONE comprehensive Tuition Rate** that includes registration, text books and equipment, standardized testing, a fixed amount for student activities and for the class treasury, and admission to: school events, athletics and co-curriculars.

***Students who are certified by a Pastor of one of the Partner (Association) congregations are eligible to receive the Partner Student Tuition rate. These congregations collectively own and operate the schools, have constructed each school's campus, and together provide over 1.5 million dollars annually towards the operation of the schools.

A non-refundable Tuition Deposit of \$200 will be required at the time of registration. This \$200 will be applied as a down payment towards the comprehensive tuition rate. If a student decides not to attend, the \$200 will be forfeited.

Some specialized courses (i.e. Art) have an additional fee to cover the cost of consumable materials and supplies. This is also true for individual instruction for instrumental or vocal music. They are added to student accounts after the semester has begun. These fees vary and will reflect actual school expenditures. Additional fees are also charged for course program changes including additions or withdrawals after the registration process is completed (\$25), participation in sports programs (\$75 per sport), and transcripts (\$5).

Withdrawal: Any student withdrawing after the first six weeks of school will be charged the tuition for the full semester.

Four payment schedules are offered. Parents select a payment plan at the time of registration each year.

ANNUAL PLAN: The remainder of the comprehensive tuition is due on July 25, 2010. If full payment is received or postmarked on or before the due date, families will receive a **discount of \$100.00** off the comprehensive tuition rate. **(This discount is per family, not per student.)**

SEMESTER PLAN: The remainder of the comprehensive tuition is due in two installments on July 25, 2010, and on December 5, 2010. If payment is received or postmarked on or before each due date, families will receive a **discount of \$25 per semester** off the comprehensive tuition rate. **(This discount is per family, not per student.)**

QUARTERLY PLAN: The remainder of the comprehensive tuition is due in four installments on June 5, 2010, September 5, 2010, January 5, 2011, and March 5, 2011.

MONTHLY PLAN: The remainder of the comprehensive tuition is due in twelve monthly installments, June 2010 through May 2011. **This plan automatically withdraws monthly (ACH) from your account. There is a one-time charge of \$40.00 per family per year.**

ALL FAMILIES ON THE MONTHLY PLAN MUST PAY AT LEAST 3 MONTHLY PAYMENTS BEFORE SCHOOL HAS STARTED TO ALLOW YOUR STUDENT TO BEGIN!

The comprehensive tuition does not reflect the full cost of providing a quality Christian education. All students benefit from the generous gifts of individuals and organizations committed to our ministry. Our projected budgeted cost per student for the 2010-2011 school year is \$10,238.00. This amount is for operating expenses only and does not include capital projects. If you believe the Lord has blessed you with the financial resources, we ask you to prayerfully consider making a donation to cover the difference between the cost of educating your student and the actual tuition you will be billed. If you are not able to make a contribution for the full difference, any amount you are able to contribute will help make a quality Christian education available to more families.
